


Honorable Mention: PTO Contribution Arrangement Convert days to dollars

Allows employees with unused vacation hours to convert them to retirement plan contributions

Can be treated as a pretax benefit, like normal employee deferrals.

Alternatively, the plan can treat the amounts as employer profit sharing, converting the excess PTO amounts to employer












Identity Theft Protection
